## **BOOTH RULES**

### **BOOTH SPACE**

Festival hours are 8am-7pm. Set up will begin at 6am, and all vehicles must be out of the festival area no later than 7:30am. Parking is available on side streets and security will be provided. Booths may be taken down beginning at 6pm, with musical performances to continue into the evening.

Vendors will receive confirmation of booth assignment, with a site map. Booth numbers will be marked on the street. Sorry, booths cannot be held without payment.

Booth fee is \$70 until September 14th. After the deadline the price is \$80. Electricity can be provided at a cost of \$15 for a 110 outlet and \$25 for a 240 outlet. Water can be provided at a cost of \$10.

### **REGULATIONS**

1. Booth fees are non-refundable unless inclement weather forces closure of the festival before 2pm
2. Booth space may not be shared or transferred
3. Food and beverages may only be sold at food booths
4. Festival volunteers will provide trash bags to vendors. Bagged trash may be placed on the street for pickup on the festival has ended
5. Trash receptacles will be placed throughout the festival for the public and may not be brought into booths
6. Electricity will be provided for a fee. Please indicate your preference on the application. Electricity cannot be "shared" between booths.
7. **NO GENERATORS ARE ALLOWED. NO MOTORIZED VEHICLES OF ANY KIND ARE ALLOWED ON FESTIVAL GROUNDS AFTER 7:30am**
8. No toy or real weapons, drug paraphernalia, or alcohol-related items may be sold
9. No illegal items may be sold
10. Vendors must provide their own tables, tents, chairs, and rack covers. We recommend weighted anchors, as canopy stakes may not be driven into the asphalt
11. Portalets will be placed around the perimeter of the festival. A handicapped accessible portalet will be located at 5<sup>th</sup> and Mobile Streets
12. Vendors bear responsibility for set-up and security at their booths. The festival organizers will not be responsible for loss or damage of any kind
13. **All sales will be conducted between the vendor and the purchaser. Vendors are responsible for collecting and remitting Mississippi sales tax of 7 percent for non-food items and 9 percent for food items to the Mississippi State Sales Tax Commission on all sales made during the festival**
14. Organizers reserve the right to refuse any application. Vendors who fail to comply with the regulations will not participate in future festivals
